Pursuant to GPPB Resolution No. 40-2017, the undersigned, hereby issues this Blacklisting Order to the entity hereafter stated:

- 1. Triple Jo Construction Services with PCAB License No. 49250 and PhilGEPS Certificate Reference No. 2021062606211786750648 having business address at Blk 26 Lot 35 East Villas Subdivision, Brgy. Estefania, Bacolod City, Negros Occidental is hereby SUSPENDED/DISQUALIFIED from participating in all government procurement for one (1) year starting from 24 May 2023 to 23 May 2024.
- 2. Specific ground/offense committed: Poor performance by the contractor or unsatisfactory quality and/or progress of work arising from his fault or negligence as reflected in the CPES rating sheet Negative slippage of 15% and Willful or deliberate abandonment or non-performance of the project or contract by the contractor resulting to substantial breach thereof without lawful and/or just cause.
- 3. The penalty is being imposed in connection with the following procurement details:
 - a. Project Name: Construction of One (1) Storey-Three (3) Classroom School Building with Common Toilet at Bugtong Elementary School
 - b. Project Location: So. Bugtong, Brgy. Tan-awan, Kabankalan City
