3. As stipulated in Section 11.2.6 of the 2016 Revised IRR RA 9184, unless sooner removed for a cause, the above-mentioned members of the BAC and BAC Secretariat shall have a fixed term of **one (1) year** reckoned from the date of appointment (i.e., date of issuance of this Memorandum), renewable at the discretion of the Hed of the Procuring Entity.

4. The BAC and the BAC Secretariat shall function based on Section 12.1 and Section 14.1 of the 2016 Revised IRR of RA 9184, respectively.

5. This designation is in addition to the current duties and responsibilities of the above-mentioned personnel and does not carry with it personnel any other additional compensation except for honoraria allowed by relevant issuances subject to the satisfaction of the documentary requirements, availability of funds, and the existing accounting and auditing rules and regulations.

6. Furthermore, this Office has ensured that there was no discrimination on the account of age, gender, civil status, disability, religion, ethnicity, political affiliation, or any other similar factor or circumstance that run counter to the principles of equal opportunity in the designation of the members of the BAC and BAC Secretariat.

7. Strict compliance of the duly reconstituted BAC and BAC Secretariat to and wide and immediate dissemination of this Memorandum are desired.
