 - b. ADMINISTRATIVE OFFICER V for Elementary and Secondary School Principals/Head Teachers/Teachers-In-Charge,
 - SCHOOLS DIVISION SUPERINTENDENT for all Division Office Personnel (OSDS, CID and SGOD).
- 3. Submission of SALN shall be by school and must be accompanied by the attached Transmittal (Annex A) for records purposes.
- 4. Failure to comply shall be ground for administrative action.
