- In preparation for opening of classes for SY 2020-2021 pending decision of DepEd EXECOM, and instructional delivery adjustments, due to COVID19 Pandemic; Schools, District and Division Office are hereby required to prepare a Learning Continuity Plan that would prepare school, teachers, learners and parents on new and emerging modalities of learning delivery.
- 2. As such, The Division Office hereby organizes the Curriculum Cluster (See Enclosure A) to assist schools and districts in preparation, quality assurance, delivery/implementation, M&E and provision of Technical Assistance to schools and districts towards the realization of the goals and mandate of Sulong Edukalidad. Each team may recommend an additional five members with expertise in the curriculum, ICT literate and Learning Resource evaluator/assessor for quality assurance. Additional designations do not carry additional remuneration nor priority for promotion.
- 3. Curriculum Clusters shall have the following functions:
 - Generate data of schools available learning resources for online and offline curriculum delivery by grade level, subject area and other learning essentials.
 - Provide Technical assistance to schools in preparation of continuity plan and delivery of curriculum in online and offline platforms.
 - Quality assure learning resources and materials and monitor implementation for provision of TA.
 - d. Ensure quality delivery of curriculum through appropriate interventions in collaboration with teachers, school heads and learners.
 - Identify and generate partnerships for ICT based/online capability building platform and learning resources repository.
 - f. Perform other functions as directed by higher Office.
- Initial data requirements for readiness assessment and continuity planning are found in Enclosure B.
- All DepEd personnel are advised to strictly observe physical distancing and other COVID 19 health and safety protocols. Meetings must be done online and unless cleared by the Department.
