This is part of the City's month-long celebration of the 27th National Children's Month. The 27th National Children's Month Celebration 2019 is dedicated to offer a vision of the child as an individual, as a family member and as member of the community with rights and responsibilities appropriate to his or her age and stage of development. Part of this Children's Month Celebration is the Juvenile Justice Consciousness Week on November 25-29, 2019 as per DepED- DM 182, S.2017 to raise the consciousness of the community on restorative justice as an approach in resolving conflicts with maximum involvement of the offender, the offended party and the community. Restorative justice aims to bring reparation for the victim, reconciliation for the offender that s/he can be reintegrated into the society.

It is on this premise that the City Social Welfare & Development Office would like to seek for your unselfish support as we conduct Quiz bee, Poster Making Contest and Extemporaneous Speech Contest on November 26, 2019 at the Function Room City Hall. This is in partnership with the United Architects of the Philippines- Buglas Sur Chapter and the City Prosecutor's Office. The primary objective of this activity is to raise the level of awareness of students on the rights of children in conflict with the law and extend to them the benefit of restorative justice, the justice that heals.

As mechanics for the said activity, we would like to request the 22 public high schools to participate by identifying contestants for each category preferably 3rd year or 4th year students.

- For the Extemporaneous Speech Contest (1 contestant per District) and Quiz bee (2 contestants per school), a briefing from the examiner herself Fiscal June Ann Q. Bernal with the coaches will take place a week before the contest proper. As soon as Fiscal Bernal confirms the date and venue, we will update your office immediately;
- For the poster making contest (1contestant per school), the United Architects of the Philippines- Buglas Sur Chapter members will explain the guidelines on November 26, 2019. We will provide for all the materials to be used during the contest;
- 3. Winners will receive tokens and a certificates.
- 4. Lunch will be serve to all (4) contestants and (1) coach from the 22 participating schools.

We are hoping that this will espouse optimal level of participation among children in pursuit to better understand the predicament of our children in conflict with the law (CICL).

Guidelines and Mechanics

- 1. The coverage of the quiz bee includes Republic Act No. 9344 and Republic Act No. 10630..
- 2. It is open to schools as invited.
- 3. The group will write their answers at the black part of the illustration board.
- All groups will answer the same set of questions in writing. Before the question is read, the group must raise their markers (chalk).
- There will be three (3) components in the competition namely: Elimination Round, Semi-Final Round and the Final Round.
- 6. The elimination round has seven (7) questions worth 2 points, the semi-final round has nine (9) questions worth 3 points and in the final round has seven (7) questions worth 5 points.
- 7. In the elimination round, only the top six (6) groups will qualify to the next (semi-final) round.
- 8. At the end of semi-final round, only the top three (3) groups will move to the final round.
- 9. The questions will be read by the quizmaster twice.
- 10. After the second (2nd) reading, the Quizmaster shall say "go", only then the groups be allowed to write their answers. Automatically, the (10) second time-limit will begin with the word "go" by the Quizmaster.
- 11. After the time-limit, the whistle is blown by the time-keeper. The groups must stop writing and must raise their answer boards.
- 12. The Quizmaster shall read and verify the groups answer.
- 13. The group who gets the highest number of points is automatically declared the champion or the runner-up as the case may be. In case of a tie, a clincher question shall be asked. First to get a score shall be declared winner.
