The Department of Education, through the Bureau of Learning Delivery (BLD) in partnership with the Cultural Center of the Philippines (CCP) Arts Education Department and the University of Santo Tomas Senior High School Department, shall be facilitating a series of mentoring programs under the **2023 CCP Arts Academy** from July 16 to 22, 2023 at the University of Santo Tomas (UST) Senior High School Building, España, Sampaloc, Manila.

The program aims to provide teachers from the **Senior High School (SHS) Arts and Design Track, Humanities and Arts-related SHS subjects, and the Special Program in the Arts (SPA)** specially designed professional and specialized mentoring program on their respective art forms to build their capacities and advance their artistic development by focusing on production and performance techniques, principles/processes, art knowledge and skills, and pedagogical approaches. Moreover, it aims to develop teaching materials that utilize the integration of the core elements and processes of art making and the available technological advancement.

In addition, the travel authority of these teachers shall be recommended for approval by the Schools Division Superintendent/Regional Director and for approval of the Undersecretary for Operations as stipulated in DO 1, s. 2023.
