1. In compliance with the provisions of Republic Act 6713, otherwise known as the Code of Conduct and Ethical Standards, all teaching and non-teaching personnel of this division are required to submit to the Administrative Office **two (2) original signed copies of Statement of Assets, Liabilities and Net Worth (Revised 2015)** not later than **February 28, 2022**.
2. For purposes of the filing and accomplishing the SALN, and to ensure that office and school operations will not be affected due to the compliance of this memo, and likewise as prescribed by law, the following shall be authorized to administer oath for said SALN Forms to wit:
 - a. **ELEMENTARY and SECONDARY SCHOOL PRINCIPALS / HEAD TEACHERS / TEACHERS-IN-CHARGE** - for all teaching and non-teaching personnel in their respective schools;
 - b. **ADMINISTRATIVE OFFICER V** - for Elementary and Secondary School Principals/Head Teachers/Teachers-In-Charge,
 - c. **SCHOOLS DIVISION SUPERINTENDENT** - for all Division Office Personnel (OSDS, CID and SGOD).
3. Submission of SALN to the Records Section shall be by school and must be accompanied by the attached Transmittal (Annex A) for records purposes.
4. Everyone is enjoined to comply with these guidelines to avoid legal impediments.
