SUBMISSION OF REQUIRED DOCUMENTS FOR THE ONE-TIME GRANT OF RICE ALLOWANCE TO QUALIFIED GOVERNMENT EMPLOYEES

- 1. In coordination with the National Food Authority, the required documents to facilitate the onetime grant of rice allowance for qualified government employees are as follows:
 - a. Authorization letter for the Focal Person issued by the Head of Agency
 - b. Master List of Beneficiaries in the new prescribed format
 - c. Acknowledgement receipt per unit/office supported with attached photocopy of one government-issued ID (Annex A)
 - d. Notarized Special Power of Attorney executed by the employee beneficiaries to Focal Person for the withdrawal and receipt of the rice allocation (Annex B)
- 2. In compliance thereof, the Authorization Letter and the Master List shall be prepared by the OSDS Admin Section. The Acknowledgement Receipt and the Special Power of Attorney shall be prepared and submitted in two copies by the school heads. Junior High Schools shall submit a separate set of compliance for their respective Senior High Schools. - 3. The deadline for submission of the required complete documents is on April 5, 2023 at the Records Unit. In the exigency of service, the in-charge personnel of the Admin Section will be available to receive submissions until 5 P.M.
