REMINDER ON UPDATING OF COVID-19 VACCINATION OF LEARNERS IN THE LEARNER INFORMATION SYSTEM (LIS)

- 1. Pursuant to DepEd Planning Service Memorandum OUCOS-PS-2022-012 from the Office of the Director dated 07 February 2022 regarding Daily Updating Of Learner's Vaccination Status and Division Memorandum No. 303, S. 2021 dated November 30, 2021 on the Submission of Pediatric Vaccination Data, this Office reminds the School Heads to accomplish the report requested.
- 2. In line with this, the Elementary & Secondary classroom advisers shall regularly update their report on the pediatric vaccination data of their respective learners and submit to their respective School Heads based on COVID-19 Learner Vaccination Tagging in the Learner Information System (LIS).
- 3. In support of the Pediatric Vaccination against COVID-19, the video/audio clip from the COVID-19 Vaccine Myth-Busting webinar should be played in school entrances or lobby. The link of the video/audio clip may be obtained from the Nurse-In-Charge of the District.
- 4. Likewise, this Office requests all Schools and Learning Centers to adopt the Vacc2School Ligtas na Bakuna para sa Balik-Eskwela! Brand Guide and Installation of Pediatric Vaccination Tarpaulin as stipulated in the Division Memorandum No. 081, s. 2022.
- 5. In the interest of public health and safety, all teaching and non-teaching DepEd personnel are reminded to strictly comply with the existing IATF protocols and minimum public health standards.

In line with DepEd Task Force COVID-19 (DTFC) Memorandum No. 327, the Public Affairs Service (PAS) created the **Vacc2School:** Ligtas na Bakuna Para sa Balik-Eskwelal Campaign to encourage the Department's teaching and non-teaching personnel to take part in the immunization program of the national government. The Campaign was developed through the help of the Department of Health (DOH) and DepEd member-offices of the DTFC and was approved by Secretary Leonor Magtolis Briones on May 5, 2021.


