- 1. RA 9155 or the Governance of Basic Education Act of 2001 requires that a school head shall be both an instructional leader and administrative manager. RA 10533 or the Enhanced Basic Education Act of 2013 implies that school heads/principals should possess skills for them to properly play their roles as academic, administrative, and community leaders in the Department of Education (DepEd).
- 2. With this premise, DepEd Region VI established the School Heads Academy (SHA) in partnership with State Universities and Colleges (SUCs)/Higher Education Institutions (HEIs) in the delivery of professional development course/subjects leading to a post-graduate degree in education for the development of future principal's work-related potentials.
- 3. One of the objectives of the SHA is to assist the scholars to undergo a one (1) year prescribed curriculum with the partner SUCs and HEIs and implement a Re-Entry Action Plan (REAP) as final requirement of the academy prior the completion ceremony. For this purpose, this Office has assigned a REAP mentor to each SHA Scholar. The list of the SHA scholars and their respective REAP mentors is attached as Enclosure No.1.
- 4. In the implementation of the REAP, the SHA scholars and their respective REAP mentors are expected to adhere to the timeline herewith attached as Enclosure No. 2.
