1. In the exigency of the service and to ensure the continuous and effective delivery of services, Undersecretary and Chief of Staff **Epimaco V. Densing III**, is hereby designated as the permanent representative of the Department of Education (DepEd) to the National Intelligence Board (NIB).
2. This is pursuant to Section 7 (8), Chapter 2, Book IV, Executive Office No. 292 instituting the Administrative Code of 1987, which provides that the Secretary has the power and function to delegate authority to officers and employees under her direction in accordance with the Code.
3. The aforementioned assignment shall not preclude the Secretary from exercising the functions delegated to the permanent DepEd representative. Moreover, Undersecretary Densing III, as alternate representative, shall consult with the Secretary all decisions pertaining to his representation in the NIB. He shall also submit to the Secretary regular reports on his attendance to Board meetings.
4. This Order takes effect upon its issuance and shall remain effective until rescinded or revised.
5. Immediate dissemination of this Order is directed.
