



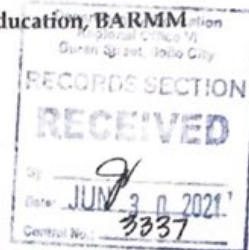

The Singapore Cooperation Programme (SCP), in coordination with Technical Education and Skills Authority (TESDA), announces its online training program on Transforming Education in the 21st Century. The details of the program are as follows:

Course Title	Transforming Education in the 21 st Century: The Singapore Experience
Course Schedule	Date 13-17 September 2021 The synchronous online sessions will be conducted from 1:00pm to 5:30pm (UTC +8, Singapore Time) daily
Target Participants	Mid to Senior level officials involved in education policy making

Considering the current pandemic situation and travelling restrictions in our region, the SCP has decided to implement this course via online mode using the **Zoom video conferencing** platform.

b. Must be 50 years old below.	
c. At least five (5) years of service in the government (DepEd) at the time of nomination	
d. Must be computer literate and have access to stable Internet connection to enable them to participate in online interactions.	
e. Able and willing to utilize course learning as well as share them with other upon completion of the program.	
f. Must hold a permanent appointment at the organization nominating him/her	
g. Must have no pending administrative and/or criminal case	
h. Must have a college degree and/or sufficient demonstrated ability and experience related/relevant to the course he/she is applying for	
i. Must have a good command of the English language (spoken and written)	
j. Must have professional development needs aligned with the KRAs of the organization.	
k. Must have outstanding accomplishments related/leading to the program applying for	
l. Must have no pending nomination for scholarship in another program/course or have already rendered the required service obligation for a scholarship previously enjoyed	
m. Physically and mentally fit	

The **Participant Nomination Form** and required documents must be submitted via email at scholarships@deped.gov.ph on or before **July 9, 2021**. Furthermore, candidates will undergo an **interview screening** that will be conducted by TESDA on **July 22, 2021**.

- ✓ Must have a college degree and/or sufficient demonstrated ability and experience related/relevant to the course applied for
- ✓ Must have no pending administrative and/or criminal case
- ✓ Must have no pending nomination for scholarship in another program/course
- ✓ Must have already rendered the required service obligation for a scholarship previously enjoyed
- ✓ Must meet the position level, age, education and experience required and specified by the donor country/organization/course
