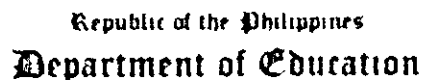

10. The LAC shall detail the following in the Standard Operating Procedure:

- a. A Supervisor/Teacher/Lead Teacher shall be assigned to at least three (3) schools in one testing center. The Supervisor/Lead Teacher will coordinate the Region 1 Specialist Coordinator and the Program Director/Supervisor. There shall be only one Supervisor/Teacher/Lead Teacher per testing center. The Supervisor/Teacher/Lead Teacher shall be a teacher from the State.
- b. A second examiner shall be assigned per school in the testing center. The second examiner shall be a Missouri teacher.

11. Prior to the test administration, a virtual orientation will be conducted by the LAC. This will be attended by the Regional and District School Administrators, Regional Coordinator, Coordinators of TCUs, DTCUs, and other key testing personnel who will be involved in the examination. Meeting details will be sent to the Regional LAC Coordinators and DTCUs.

12. On the examination day, the participants are required to bring the following:

- a. Registration form signed by the participant's supervisor
- b. Identification required by IS
- c. A copy of most recent ACT scores (if applicable) and transcript of scores
- d. Any other IS, Missouri Department of Education, or State approved materials

13. A MOA representative is authorized to use the computer test materials. Schools are required to follow the MOA Standard.

14. A letter of test planing details will be sent to the examiners for their information. All changes in information regarding the course of tests should be disseminated through an official communication.

15. Health and safety priorities must be followed in all the activities to be done.
