**CONDUCT OF REMEDIAL CLASSES DURING SUMMER 2020 AND MAKE UP CLASSES
DURING SY 2020-2021**

TO: Assistant Schools Division Superintendent
Chief Education Supervisors, CID & SGOD

Public Elementary & Secondary School Heads
All Others Concerned

1. In consonance with the DepEd Memorandum 051, s. 2020 re: Guidelines on the Conduct of Remedial, Advancement, and Enrichment Classes during Summer 2020, the SDO of Kabankalan City will conduct the Remedial Classes this summer and Make Up Classes during the SY 2020-2021.
2. The objectives of the Remedial Classes are as follows:
 - a. provide all learners who receive a grade lower than 75 an intervention through a remediation to be promoted to the next grade level; and
 - b. ensure the delivery of quality basic education services to all learners across learning areas and grade levels in preparation for the opening of classes.
3. Schools who are implementing the summer remedial classes shall prepare an Implementation Plan (IP) approved by the SDS.
4. For those schools who opted to conduct the make-up classes in place of remedial classes during the summer, the school shall prepare their Implementation Plan before the start of the school year allowing learners to stay in school beyond their regular class schedules to attend after-class interventions in the subject area/s they failed.



In compliance with EO No. 112 where physical classes are suspended in basic education during the ECQ and GCQ, until there is a regulation by the local authorities permitting learners and teachers to leave their home for school purposes the following learning modalities shall be utilized or adopted during the summer classes:
 - a. Distance Learning
 - Online platforms
 - Printed modules
 - b. Blended Learning
