





Subject: VISION SCREENING TEST FOR ALL KINDERGARTEN THROUGH  
PROJECT P.U.P.I.L (Pamaraan Upang Paningin Isaalang-alang Lagi)

1. Relative to RA 10157 otherwise known as the kindergarten Education Act which makes Kindergarten the first stage of compulsory and mandatory formal education and now be an integral part of the basic education system of the country. The Schools Division Office of Kabankalan City strengthens its measures in ensuring the welfare of the learners, one of which is through vision screening test that shall immediately address vision problems among our Kindergarten pupils.
2. Project P.U.P.I.L aims to:
  - a. Identify children who have or at risk of developing vision problems;
  - b. Address vision problems among our learners, through proper referral for intervention thus, improving school performance;
  - c. Strengthen health promotion and early detection of vision problems; and
  - d. Raise awareness on proper eye care and proper nutrition which contributes to visual health.
3. Health and Nutrition Personnel shall be responsible in the conduct of the aforementioned undertaking. Attached in Enclosure A is the list of Kindergarten schools with their respective schedules.

4. For schools with one day schedule, kindergarten teachers shall gather all the pupils in the morning, while schools with 2 day schedule, teachers shall identify and provide a list or groupings for the two day vision screening test.
5. All Elementary School Heads are hereby enjoined to support this activity.
