Contest Guidelines

POSTER-MAKING CONTEST GUIDELINES

- 1. All contestants are entitled to one coach or chaperon.
- 2. Each contestant will bring 20"x30" illustration board, which will serve as their canvass. The name and school should be pasted at the back of the board.
- The contestant will bring basic drawing and coloring materials. and limited to crayons, oil pastels, coloring pencils, water color, poster paints and markers.
- 4. After the announcement of the theme of the contest, the contestants are given five (5) minutes to consult with the coaches. After that, the contestants are given two (2) hours to work on their entries. No more coach or chaperone is allowed to interfere during this period.
- 5. The artwork shall follow a PORTRAIT orientation. No text or mark identifying the contestant should appear on the artwork.
- 6. The facilitator shall display a wall or digital clock so that contestants are guided on the time limitations. The facilitator should also announce the following during the contest time: last one hour, last thirty minutes, last fifteen minutes, last five minutes after, and last minute.
- 7. After the contest work period, all entries will be submitted to the facilitator.
- 8. Entries will be judged on the following criteria:

•	Overall presentation included creativity, color harmony, etc.	50%
•	Relevance to the theme	40%
•	Originality	10%

9. After the adjudication and tabulation of results, the Panel of Judges shall announce and award the winners of the Division contest. The decision of the Panel of Judges shall be final.

II. ESSAY-WRITING CONTEST GUIDELINES

- 1. All contestants are entitled to one coach or chaperon.
- Laptops/computers will be used during the contest. Contestant may bring their own laptop or
 use a laptop provided by the school. Internet access of the laptop should be turned off
 throughout the duration of the contest. Designated facilitator will monitor the contestants
 during the work period.
- After the announcement of the theme of the contest, the contestants are given five (5) minutes
 to consult with the coaches. After that, the contestant are given two (2) hours to work on their
 entries. No more coach or chaperone interfere is allowed during this period.
- 4. Works must follow the specifications below:

	Paper Size	A4
•	Font Style	Arial
•	Font Size	12
	Alignment	Justified
-	Margin	1 inch on all sides
•	Spacing	double space

- 5. Works must be in English. Maximum word count is 2, 000. Minimum word count is 750.
- The name of the contestant or school being represented should not appear in any part of the work. Contestant will be given Reference Numbers which will be used to identify the entries.
- 7. The facilitators shall display a wall or digital clock so that the contestants are guided on the limitations. The facilitator should also announce the following during the contest time: last one hour, last thirty minutes, last fifteen minutes, last fifteen minutes, last five minutes, and last minute.
- 8. All entries should be saved using the Reference Number as file name. after the contest period, entries will be submitted through thumb drives provided by the facilitator.
- 9. Entries will be judged on the following criteria:

•	Substance and content	40%
•	Relevance to the theme	30%
•	Originality	15%
•	Mastery of the English Language	15%

10. After the adjudication and tabulation of result, the Panel of Judges shall announce and award the winners of the contest. The decision of the Panel of Judges shall be final.
