Subject: **EMERGENCY MEDICAL RESPONDER'S TRAINING COURSE for the
Division Front Line Responder's Team (FLRT)**

1. Pursuant to Republic Act 10121 which recognizes the critical role of the Education Sector in institutionalizing and main streaming DRRM and CCA into Deped's Systems, processes and policies, the Schools Division Office of Kabankalan City Deped as member of the National and Local DRRM Council and integrating Disaster Risk Reduction Management into the school curriculum will capacitate teaching and non-teaching personnel in Disaster Preparedness.
2. There will be a 5-day live in training on April 23-27, 2019 at the Division Conference Hall.
3. The training aims to:
 - a. Develop knowledge and skills on DRRM, CCA, EiE to share and implement and mainstream in their area of work
 - b. Gain understanding on the procedures of Emergency Response
 - c. Acquire knowledge on Safety and Protection of Life
 - d. Understand the importance of providing pre-hospital Emergency Care in school
 - e. To be able to determine appropriate medical intervention in a given emergency situation
 - f. To be able to perform and carry out the principles of Basic Life support
4. Participants should bring their beddings and change of clothes for 5 days
5. Food and other incidental expenses incurred in the conduct of the said activity shall be charged against HRTD Funds while travel expenses incurred by the participants shall be charged against SCHOOL MOOE subject to usual accounting and auditing rules and regulations.
