**2019 ESKWELA KOOPERATIBA NATIONAL CONFERENCE FOR THE DEVELOPMENT  
OF LABORATORY AND YOUTH COOPERATIVES**

The City Government of Imus, through the City of Imus Local Council for the Protection of Children (LCPC) and the City of Imus Cooperative, Livelihood, Entrepreneurial and Development Office (CICLEDO), in partnership with the Cooperative Development Authority (CDA), and the Imus Cooperative Federation (ICF), will conduct the 2019 *Eskwela Kooperatiba* (EK) National Conference for the Development of Laboratory and Youth Cooperatives with the theme, Children and Youth, the New Face and the Next Phase of the Philippine Cooperative Movement from November 14 to 16, 2019 at the Tagaytay International Convention Center, Tagaytay City, Cavite.

The activity aims to

1. monitor the progress of the programs arising from the 2018 EK national conference;
2. serve as a launchpad for various programs for the development of laboratory and youth cooperatives, especially on youth entrepreneurship; and
3. institutionalize the EK Program through local government units (LGUs) nationwide.

Target participants are local officials, including *Sangguniang Kabataan*, cooperative officers and youth affairs officers of LGUs, focal persons of LCPC, board of directors, officers and managers of cooperatives, laboratory cooperative officers, and teachers, principals, superintendents, and officials of the Department of Education.
